

CONSTITUTION FOR THE SUNDRY SLOW PITCH 'FUN' BASEBALL LEAGUE

1) NAME & PURPOSE

SUNDRY BASEBALL LEAGUE

THE PURPOSE OF THIS LEAGUE IS TO PLAY BASEBALL GAMES AT A FUN LEVEL AND GET OUT OF THE HOUSE, SOCIALIZE AND HAVE FUN.

2) MEMBERSHIP

THE BASEBALL LEAGUE IS OPEN TO ALL PERSONS OVER THE AGE OF 16 AND UNDER THE AGE OF 100.

ANY PERSON UNDER 16 HAS TO BE IDENTIFIED AND AGREED UPON BY OPPOSING TEAM BEFORE GAME STARTS.

3) EXECUTIVE AUTHORITY

THE RULING BODY OF THE LEAGUE WILL CONSIST OF A BOARD OF GOVERNORS.

THE RULES (3.3) SHALL FILL THE FOLLOWING POSITIONS: PRESIDENT, SECRETARY, TREASURER, TOURNAMENT COMMITTEE, SOCIAL COMMITTEE, DIAMOND COMMITTEE.

ELECTIONS WILL BE HELD AT THE MEETING IN THE FALL. OPEN POSITIONS WILL BE FILLED.

THE BOARD OF GOVERNORS CAN CHANGE ANY RULES WITH A MINIMUM 51% VOTE OF THOSE PRESENT.

ANY TEAMS THAT DO NOT ATTEND A SCHEDULED MEETING WILL NOW BE FINED. FINES MUST BE PAID PRIOR TO THE TOURNAMENT. 1st MISSED MEETING = \$50, 2ND MISSED MEETING = \$100 AND 3RD MISSED MEETING = OUT OF LEAGUE. NO EXCUSES WILL BE ACCEPTED. TOTALS CARRY ON FROM EACH YEAR STARTING APRIL 22, 2009. TEAMS WHO ARE EXPELLED FROM LEAGUE DUE TO MISSED MEETINGS ARE NOT ENTITLED TO ANY LEAGUE MONEY REFUND.

NEW TEAMS – THE EXECUTIVE HAS FIRST RIGHT OF REFUSAL AND WILL DECIDE WHICH TEAM WILL JOIN THE LEAGUE IF THERE IS MORE THAN ONE TEAM INTERESTED.

4) AMENDMENTS TO THE CONSTITUTION

THE BOARD OF GOVERNORS CAN CHANGE ANY ITEM OR ADD TO THE LEAGUE CONSTITUTION AT ANY TIME WITH A VOTE OF 51% OF THOSE PRESENT.

5) PLAYING RULES

EVERY YEAR LEAGUE RULES AND TOURNAMENT RULES WILL BE REVIEWED AND AGREED UPON BY ALL TEAMS.

6) HARASSMENT AND VIOLENCE POLICY

UNDER NO CIRCUMSTANCES SHALL ANY PERSON(S) WITHIN THE SUNDRY BASEBALL LEAGUE PARTICIPATE IN ANY PHYSICAL VIOLENCE OR DISCRIMINATORY LANGUAGE TO ANY OTHER PERSON(S) WITHIN SAID LEAGUE.

ANY PERSON(S) INVOLVED IN SUCH ACTIONS SHALL BE REMOVED FROM THE GAME AND PLAYING FACILITY AND RECEIVE A MINIMUM ONE GAME SUSPENSION TO BE SERVED THE FOLLOWING GAME IMMEDIATELY AFTER THE DATE OF THE OFFENCE. MANAGERS AND COACHES ARE ENCOURAGED TO POLICE THEIR OWN PLAYERS AND REMOVE ALL PARTIES INVOLVED INCLUDING SPECTATORS. MANAGERS AND COACHES FOUND IN BREACH OF THIS POLICY, UPON REVIEW BY THE EXECUTIVE COMMITTEE WILL BE SUBJECT TO IMPOSED FINES AND OR ELIMINATION FROM THE SUNDRY BASEBALL

LEAGUE. EFFECTIVE IMMEDIATELY WITH NO REFUND OF LEAGUE FEES PAID FOR THE CURRENT SEASON OR ACCRUED PROFIT WITHIN THE LEAGUE ITSELF
IN SUMMARY THIS IS A ZERO TOLERANCE POLICY. MANAGERS ARE TO SHARE THIS INFORMATION WITH ALL EXISTING AND NEW PLAYERS IMMEDIATELY AND GOVERN YOUR TEAMS ACCORDINGLY
THIS POLICY IS SUBJECT TO ADDITIONS WITHOUT NOTICE –

7) LEAGUE TERMINATION

7.1 IF THE LEAGUE FOLDS/TERMINATES, ALL MONEY IN THE BANK WILL BE DIVIDED EQUALLY AMONGST CURRENT TEAMS.

8) WEAPONS-IF ANY PERSON IS TO YIELD A WEAPON OF ANY KIND, SAID PERSON SHALL NO LONGER BE WELCOME AT SUNDRY FUNCTIONS, GAMES, OR TOURNEYS. SEE: CRIMINAL CODE OF CANADA. DATED OCT 18/2017. (VOTED - UNANIMOUS)
